Frey presented the new federal mileage reimbursement that was passed to 65.5 cents per mile. Wolf moved to increase Mercer County mileage reimbursement to \$0.66 per mile. Bauman seconded. All voted aye. Motion passed.

Auditor Melberg gave update to the Landfill Land Lease between Mercer County and Adrian Mittlesteadt. He no longer wants to lease the land and has an interested party to sublease for the rest of his contract. Commissioners would like States Attorney opinion on this subject as well.

Auditor Melberg administered the Oath of Office to the Elected Sheriff, Terrance Ternes. Ternes requested to adopt the Mercer County Sheriff's Department Policy and Procedure Manual. Rick moved to adopt the Policy and Procedure Manual. Wolf seconded. Taylor and Folk recused themselves from the vote. Bauman aye, Wolf aye, Frey aye. Motion passed.

Treasurer Grannis gave treasures report. Commissioners would like to continue to hold monthly treasures report.

911 Coordinator/Emergency Manager Reed gave update for the discussion of separating these two positions. Reed would like to retain the Emergency Manger position after she takes office for Auditor.

States Attorney Schwarz entered the meeting. Schwarz gave his opinion on the Mannhaven lots. There needs to be some investigation on last ownership and make sure it is not with other governmental interests. Then there can be discussion about placing it on the tax sale. Schwarz also discussed the Landfill Lease and stated he would like to see the signed agreement.
