- 1. Mercer County #21 from the junction of ND Highway #200 north 2 miles to the junction of Mercer County #26.
- 2. Mercer County #26 from the junction of Mercer County #21 northwest 5 miles to the Coteau Properties office.
- 3. Mercer County #17 from ND #200 South to Mercer County #20.
- 4. Mercer County #25 from the junction of ND Highway #49 west 4 miles to the Coyote Creek Mine.

CLASS #2

- 3. Mercer County #37 from the Stanton city limits north and west 16.5 miles to the junction of Mercer County #27.
- 4. Mercer County #18 from the junction of ND Highway #200 at Hazen northeast 13.5 miles to the junction of Mercer County #37.
- 5. Mercer County #27 from the Oliver County line north 16 miles to the junction of ND Highway #1806.
- 6. Mercer County #20 from the Beulah city limits east 22 miles to the junction of ND Highway #31.
- 7. From the Oliver County line north 1 mile between section 32 and 33 T-144 R-85 to the junction of Mercer County #20.
- 8. From junction of the Hazen Bay Road and ND Highway #1806 north approx. 2 miles to the boat ramp.
- 9. From ND Highway #200 north and east to Happy Acres.
- 10. From ND Highway #1806 north and west to Beulah Bay boat ramp.
- 11. From ND Highway #1806 north to the Beaver Bay boat ramp.
- 12. Mercer County #28 from the junction of ND Highway #200 west 13 miles to the junction of ND Highway #1806.
- 13. Mercer County #26 from the junction of ND Highway #200 west 13 miles to Mercer County #21.
- 14. Mercer County #26 from the junction of Mercer County #15 west 17 miles to the Dunn County line.
- 15. Mercer County #13 from the ND Highway #1806 south 31 miles to the Morton County line.
- 16. Mercer County #21 from the Beulah city limits north to the junction of ND Highway #200.
- 17. Mercer County #21 from 2 miles north of ND Highway #200. Then 8 miles north to ND Highway #1806.
- 18. Mercer County #1 from the junction of ND Highway #1806 north 4 miles to BIA 221.
- 19. Mercer County #11 from the junction of ND Highway #1806 south 10 miles to the junction of ND Highway #200.
- 20. Mercer County #20 from the junction of ND Highway #49 west 13.5 miles to the junction of Mercer County #5.
- 21. Mercer County #5 from the junction of ND Highway #1806 south 33 miles to the Morton County line.
- 22. Mercer County #1 from the junction of ND Highway #1806 south 8 miles to the Dunn County line.

- 23. Mercer County #2 from the Dunn County line east and south 10 miles to the junction of Mercer County #5.
- 24. Mercer County #25 from the junction ND Highway #49 southwest 10 miles to the junction with Mercer County #16.
- 25. Mercer County #16 from the junction of ND Highway #49 west 7 miles to the junction of Mercer County #13.
- 26. Mercer County #14 from the junction of ND Highway #49 west 19 miles to the Stark County line.
- 27. Mercer County #9 from the junction of Mercer County #26 south 4 miles to the junction of ND Highway #200.
- 28. Mercer County #7 from the junction of ND Highway #200 south 24 miles to the Morton County line.
- 29. Mercer County #19 from the junction of ND Highway #200 south 2 miles to Mercer County #20.

Class 2 load restrictions will be effective immediately on the above mentioned county highways and will be removed from these county highways at the time the North Dakota State Highway Department removes the Class 2 load restrictions from the State Highway system in Mercer County.

<u>Class #2 Load Restrictions</u>: Single Axle, not to exceed 12,000 lbs. Tandem Axle, not to exceed 12,000 lbs. per each axle. Three Axles or more (group), not to exceed 10,000 lbs. per each axle. Maximum gross weight on axle groups of divisible loads 30,000 lbs. Gross weight not to exceed 65,000 lbs.
