Folk moved to approve Temporary Use Case #638 Energy Sand Solutions-Sand mining -S2 5-144-85, Ben Thomas-Renewal through the year. Voigt seconded. Folk amended motion to be tabled. Voigt seconded. All voted aye. Amendment carried. All voted aye. Motion carried.

Voigt moved to award the Zoning Ordinance Update/Rewrite RFP to Apex, Donavan, and Kaffar. Folk seconded. All voted aye. Motion carried. Recorder Shannan Senger presented information regarding the purchase of a scanner. Folk moved to approve the presented scanner purchase, which includes costs of \$15,303.56 large scanner, \$970.43 touchscreen monitor with adjustable arm, and \$1,120.06 maintenance agreement. Voigt seconded. All voted aye. Motion carried. Pierce noted that he would like to see at least two bids on requested purchases from departments.

NDACo CEG Representative Michael Wolf and Michael Casey explained the higher insurance rates that Mercer County will be experiencing over the next couple years due to the loss of a sheriff's deputy in the line of duty and how the CEG helps alleviate some of these high premiums.

At 11:00 a.m. Voigt moved to close the regular meeting. Folk seconded. All voted aye. Motion carried. Folk moved to open the Public Meeting for the Flood Ordinance. Pierce seconded. All vote aye. Motion carried. Director Jen Neumiller read the ordinance and noted changes of the updated Flood Ordinance. This has been the first reading of the ordinance. Second reading will be held on February 6, 2024, at 11:00 a.m. No Public comments were heard.

Folk moved to close the public meeting. Voigt seconded. All voted aye. Motion carried. Folk moved to open the regular meeting. Pierce seconded. All voted aye. Motion carried.

County Fair Board representative Jeff Klein requested \$150,000 versus the \$61,000 that was budgeted, due to extensive expenses that the Fair has experienced over the past year. Folk moved to amend the Fair Board budgeted amount of \$61,000 to \$90,000. Pierce seconded. All voted aye. Motion carried.

Treasurer Dawn Grannis gave an update on county pledges and investments. States Attorney Todd Schwarz discussed the Temporary Use Case #638 and the importance of bonds that protect the county. Folk amended the tabled motion from one year to three months. Voigt seconded. All voted aye. Amendment carried. All voted aye. Motion carried.

HR/EM Director Alice Grinsteinner discussed courthouse security and she is also suggesting an updated policy of key cards and inventory of all keys. Folk moved to approve the BND loan request of \$3,031.65 for payment of a Bayview Heights professional services bill. Voigt seconded. All voted aye. Motion carried.

Voigt requested permission for the County Road Department to upgrade County Road 20 for use during the bridge replacement. Folk moved to approve the County Road department to complete County Road 20 testing west of Beulah from Hwy 49 to the Airport. Voigt seconded. All voted aye. Motion carried. Folk moved to have a journal entry done to move \$25,000 from the building maintenance line item #441 to come out of line item #438. Voigt seconded All voted aye. Motion carried.

Folk moved to have a journal entry done to move the \$57,972.48 radio expense from the Sheriff's line item #461 to the 911 fund line item #446. Voigt seconded. All voted aye. Motion carried.
