A Special Assessment District request for a pavement improvement project in the Sakakawea Bay Cabin site was presented by the Sakakawea Bay Cabin Owners Association President John Vallely and Interstate Engineer Charlie Hankins. Association minutes showing approval of owners, project engineering plan and a resolution to establish this special assessment district is required to be completed before commission approval. Vallely also requested that the county maintenance agreement established 20 years ago for snow removal, moving ditches, crack/chip sealing, and striping be put into a written agreement and approved by the commission. All requested item information will be given to the States Attorney for review. Item was placed on the August 21, 2024, meeting agenda at 10:00 a.m.

Bauman presented two quotes from Jones Construction for the Sakakawea Estates Road improvement project. Item tabled.

Jack Schwab gave an update on the Paul Martin memorial project which is scheduled to be completed in April, 2025.

Board agreed to appoint Travis Frey as the Mercer County NDACo Delegate at the October NDACo Conference.

Folk moved to appoint Michael Berg and Jayme Boeshans to the Weed Board. Taylor seconded. All voted aye. Motion carried.

HR/EM Director Alice Grinsteinner gave an update on applications received for the Veteran Service Officer position. Grinsteinner will set up interviews with the 4 applicants that have been received and a special meeting will be held.

Folk moved to approve the July Sheriff's fees of \$38,298.06. Taylor seconded. All voted aye. Motion carried.

Grinsteinner presented the Oliver Emergency Management (EM) MOU agreement for approval. Bauman moved to approve the Oliver EM MOU agreement as presented. Folk seconded. Bauman rescinded motion. Item was put on the August 21, 2024 meeting agenda.

Sakakawea Estates Road project bids were presented from Jones Construction. Frey moved to approve the Sakakawea Estates Road project bid of \$70,887. Bauman seconded. Frey rescinded motion. Item was tabled.

Wolf stated he will notify the Auditor when all public hearing dates and times are set for the approved preliminary resolution to re-designate the elected positions of Auditor, Treasurer & Recorder to appointed positions. Taylor moved to approve moving the November 6, 2024, regular commission meeting to November 7, 2024, due to the General Election. Frey seconded. All voted aye. Motion carried.

Frey moved to approve credit card requests for the following departments; Sheriff, HR/EM, States Attorney, County Road, Extension Service, and Tax Director. Taylor seconded. All voted aye. Motion carried.

County Road Superintendent hiring decision was tabled due to Pete Johner stating to Bauman before this meeting that he would not accept the County Road Superintendent job if offered to him. Board requested a written refusal from Johner before making a final decision. This item was placed on the August 21, 2024, meeting agenda under "Other Business." Portfolio updates were given.

Sakakawea Estates Road project bids were presented from Jones Construction. Frey moved to approve the Sakakawea Estates Road project bid of \$70,887. Taylor seconded. Frey, Taylor, Folk, and Bauman voted aye. Wolf voted nay. Motion carried.

2025 Preliminary Budget was discussed and following items were amended:

- Raise Oliver County/911 Fees from \$40,000 to \$70,000.
- Change the Library mill levy from 3.12 to 3.5.
- Add \$30,000 to the expenditure line item in the Parks In Lieu Fund.

Frey moved to add back \$50,000 to Planning and Zoning, and \$50,000 to Mercer County Economic Development (MCED), then reduce the General Fund reserve by \$100,000. Taylor seconded. All voted aye. Motion carried.

Frey moved to approve the 2025 Preliminary Budget as amended. Bauman seconded. All voted aye. Motion carried.
